DISCUSSION AND POSSIBLE ACTION REGARDING THE SHEBOYGAN POLICE DEPARTMENT HIRING PROCESS

Chief Domagalski and Captain Cobb reviewed with the PFC the current process for SPD hiring.

The general discussion focused on the need for our hiring process to enable the SPD to attract and hire the best possible candidates considering the new challenges in the job market.

The discussion moved towards achieving a process that would allow staff some flexibility while including the PFC in their traditional statutory role.

It was decided, by consensus, to continue this discussion at a future meeting and that SPD staff would produce a document that would articulate the process for clarity and understanding by all involved.
