DISCUSSION AND ACTION REGARDING THE INTERVIEW TIMES FOR POLICE CANDIDATE INTERVIEWS SCHEDULED FOR THE FEBRUARY 28 TH PFC MEETING

Captain Cobb advised that one of the candidates the department would like to invite for an interview is a student at Fox Valley. There is testing occurring at the academy on the 28 th and the candidate will not be able to leave class early.
