1. OPENING OF MEETING

APPROVAL OF MINUTES

2. ITEMS FOR DISCUSSION AND POSSIBLE ACTION

DISCUSSION OF THE CURRENT FIRE DEPARTMENT HIRING LIST

Chief Romas reported that three new members were sworn in on Monday.

He stated that this is the first time the department has been at full staff since December of 2015.

DISCUSSION AND POSSIBLE ACTION REGARDING PROMOTIONS IN THE POLICE DEPARTMENT TO SERGEANT AND LIEUTENANT

Chief Domagalski reported that a Lieutenant spot opened up when Scott Mittelstadt left. The department ran a promotional process to fill that spot.

A promotional process was then run for promotion to Sergeant.

Chief Domagalski presented information about the candidates for Lieutenant and described the promotional process.

The Chief nominated and asked for approval of the promotion of Kurt Zempel to Lieutenant.

He spoke about Sgt. Zempel's background and experience.

Salary and responsibilities of the Lieutenant position were discussed.

The Chief spoke about the process for the Sergeant promotion and provided information about the candidates.

He advised it would be a strong decision to promote Andy Kundinger to Sergeant and he spoke about Officer Kundinger's experience.

Motion by Commissioner Hopp, second by Commissioner Samet to approve both promotions as suggested by the Chief.

Commissioner Jung suggested that the approvals should be taken separately and he would prefer to do them individually.

Motion by Commissioner Hopp, second by Commissioner Samet to promote Kurt Zempel.

Motion carried.

Motion by Commissioner Samet, second by Commissioner Hopp for approval of promoting Andrew Kundinger to Sergeant.

Motion carried.

Chief Domagalski concluded by speaking about the strength of the supervisory ranks, advising that the organization is on a good path for succession planning.
