3.1 Charter Ord. No. 1-21-22 / December 20, 2021 / Doc. 35: An ORDINANCE (being subject to the home rule provisions of Sec. 66.0101 of the Wisconsin Statutes) to establish the office of Director of Senior Services as a position at the department head level and to permit the City Administrator to make interim appointments to fill vacancies in all department head level appointive offices where specific provisions for filling said vacancies is not otherwise provided by state law.

City Attorney Chuck Adams presented the ordinance and answered questions. Committee members discussed interim appointments and expressed their desire for any future proposal to be more limited.
