R.O. No. 128 - 17 - 18 (8 - 7 - 17) Submitting various license applications for the period ending December 31, 2017, June 30, 2018 and June 30, 2019. Bev. Op. Lic. App. No. 0977 (Eugene A. Osbahr)

Eugene A. Osbahr failed to appear before the committee for the continued hearing on possible denial of his license application.

Motion by Alderperson Rindfleisch, seconded by Alderperson Trester, to deny the license application based upon Mr. Osbahr s record of violations related to the licensed activity, his history as a habitual law offender, and his failure to cooperate with the committee. Motion carried 4 - 0.
