## ITEMS FOR DISCUSSION AND POSSIBLE ACTION

R.O. No. 104 - 17 - 18 (7 - 17 - 17) Submitting various license applications for the period ending December 31, 2017, June 30, 2018 and June 30, 2019. Bev. Op. Lic. App. Nos. 9642 (Tiffany J. Perronne), 1766 (Taylor J. Quesinberry), 1757 (Jessica R. Charles), 1762 (Kyle R. Decker) - [CLUB], 1751 (Gewell R. James Sr.)

Tiffany J. Perronne appeared before the committee for a hearing on possible denial of her license application. The committee heard from Ms. Perronne and her witness Dave Repinski, and also the City's witness Lt. Adams, and then deliberated regarding Ms. Perronne's record.
