R.O. No. 295 - 16 - 17 (4 - 17 - 17) Submitting various license applications for the period ending December 31, 2017, June 30, 2017 and June 30, 2018. Various License Applications: Bev. Op. Lic. App. Nos. 1540 (Chris J. Amador), 1492 (Koke Mailo Podewils), 9763 (John E. Wenzel); Taxicab Driver's Lic. App. No. 1520 (Gloria Alma Rodriguez)

Chris J. Amador failed to appear before the committee for a hearing on possible denial of his license application.
