Items
2.1 and
2.2 were discussed together Handout and explanation from Sandy Rohrick regarding the proposed 2015 Health Insurance Plan Costs and High Deductible

Health Plans. Bill Adams expressed his concerns about the City's health insurance fund reserves and the HSA's with high deductible options. Tom Jocz explained to the committee that you need a strategy,

and work on a 3 year plan.

You need to know what you are trying to accomplish as far as maintaining the reserves. Discussion was held.

2.3 Res. No. 66 - 14 - 15 by Ald. Donohue, Dassler, Bohren, Hammond and VanderWeele adopting certain changes to the City's Medical Benefit Plan effective for calendar year 2015 coverage and establishing the monthly premium equivalent rates effective for January 2015 coverage and thereafter. Ald. Donohue expressed her concern that she was not comfortable on voting on this today. Motion to hold with direction from the staff to look at a couple of different high deductible plans and come back to the committee to review by Ald. Bohren, Second by Ald. Dassler - All Ayes.

2.4 G. O. No. 27 - 14 - 15 by Ald. Donohue repealing Chapter 29 of the 1975 Municipal Code and repealing and recreating Chapter 82 of the Sheboygan Municipal Code relating to personnel regulations and benefits, specifically 82 - 94 jury duty. Handout from Sandy Rohrick the revised jury duty language.

Employees who are subpoenaed and serve on jury duty on an involuntary basis on any days which are scheduled workdays for them shall be excused for the time spent in jury service and shall receive their regular rate of pay (no greater than 8 hours of pay for each full day served)

not to exceed 60 days per calendar year, subject to the following provisions:

a) Employee must present proof of jury duty service, stating the dates and hours per day served on jury duty. b) Employee shall immediately endorse his/her check for such jury service over to the human resources/payroll department. c) When employee is excused for jury service, the employee shall report back to work within one hour to complete his/her shift unless the employee chooses to utilize paid time off for the absence. The members agreed to the modification. Since these changes and the " 3 " tier retirement language were not included in the original ordinance, a motion was made by Ald. Bohren to file Gen. Ord. 27 - 14 - 15 and bring to council a substitute ordinance with the following additions; the General Guidelines for Non-Rep Post - Retirement Medical Insurance by Tier/Class and the new language for Jury Duty by Ald. Bohren, Second by Ald. Dassler - All Ayes.

3. CLOSED SESSION

3.1 A Motion was made by Ald. Bohren convene in closed session under the exemption provided in Sec. 19.85 (1)(e), Wis. Stats., for the purpose of reviewing strategy for collective bargaining negotiations, where bargaining reasons require a closed session.
