1. OPENING OF MEETING

1.1 Call meeting to order

Chair Alderperson Holzschuh called the meeting to order at 2:31 p.m.

2.3 Presentations by potential applicants for available "Class B" alcohol beverage licenses

There is presently one "Class B" alcohol beverage license available. Cynthia Yue and Kevin Knapp appeared before the committee to present their cases regarding pre-applications for the available license.

Cynthia Yue spoke on behalf of Tokyo Sushi and Steak House. Ms. Yue operates a popular Japanese restaurant in Manitowoc and is interested in opening a similar restaurant in Sheboygan in the Econo Lodge on 8th Street with six hibachi grills and also serving fresh sushi. Ms. Yue plans to invest \$550,000 in remodeling and could be open by July with a 100 person capacity.

Kevin Knapp spoke and indicated that he is purchasing the former Weimann's Sports Center restaurant at 4604 S. Business Drive and will be closing on the purchase on March 14th. Mr. Knapp plans to open a supper club (possible names are Trinity Grill or Fusion Supper Club) with a full bar and banquet area. Capacity is 74 in the lower level and 108 in the upper level. He indicated he could open within three months.
