1. OPENING OF MEETING

1.1 Call meeting to order

Chair Alderperson Holzschuh called the meeting to order at 2:31 p.m.

1.2 Pledge of Allegiance

The Pledge of Allegiance was recited.

1.4 Approval of the minutes of the December 13, 2016 meeting

Motion by Alderperson Trester, seconded by Alderperson Draughon, to approve the minutes of the previous meeting held December 13, 2016. Motion carried 4-0.

2. ITEMS FOR DISCUSSION AND POSSIBLE ACTION

Jason J. Sarabia failed to appear before the committee.

2.3 Possible action regarding Alc. Bev. Lic. No. 3044-Blondies Bar & Grill (Michael L. Kramer, Agent) and Bev. Op. Lic. No. 8875 (Renee A. Kramer)

Michael L. Kramer and Renee A. Kramer appeared before the committee. Renee Kramer indicated that they are now making certain that all patrons exit the bar by closing time.

Motion by Alderperson Draughon, seconded by Alderperson Trester, to issue warnings to both Blondies Bar & Grill and Renee A. Kramer regarding being open after hours on November 6, 2016. Motion carried 4-0.

2.4 Gen. Ord. No. 34-16-17 (12-19-16) An ordinance repealing and recreating Section 2-35 of the Municipal Code relating to privilege of the floor at Common Council meetings so as to give the city administrator and the director of planning and development the privilege of the floor

CA Adams explained that this proposed ordinance simply adds the city administrator and the director of planning and development to the list of city officials who have automatic privilege of the floor, meaning they can come up to the front of chambers and may speak from the front without there needing to be a vote of the council.

Motion by Alderperson Trester, seconded by Alderperson Draughon, to approve the proposed ordinance and submit it to the common council with a favorable recommendation. Motion carried 4-0.

2.5 Res. No. 159-16-17 (12-19-16) A resolution authorizing the City Attorney to enter into a Settlement Agreement with the United States of America regarding the accessibility of polling places

CA Adams explained that this settlement agreement was negotiated between the Justice Department and the City as a result of the Justice Department reviewing the City's polling places for technical compliance with the Americans with Disabilities Act.

Motion by Alderperson Draughon, seconded by Alderperson Trester, to approve the proposed resolution and submit it to the common council with a favorable recommendation. Motion carried 4-0.
