#### 2.4 Presentations by potential applicants for available "Class B" alcohol beverage licenses

There are presently three "Class B" alcohol beverage licenses available. Aaron Sloma, Kevin Sampson, Lisa and Paul Roberts, Manasty Lee, and Mike Eggen's representative all appeared before the committee to present their cases regarding pre-applications for the three available licenses.

Aaron Sloma spoke regarding Parker John's BBQ & Pizza. Mr. Sloma indicated they had turned in their license when they ran into structural issues, but they are now back on schedule with construction. They should be ready to open by February.

Kevin Sampson spoke on behalf of Scott Versey and Cosmic Bounce / Lakeview Wine Bar. The wine bar would be on the rooftop of Cosmic Bounce at 802 Blue Harbor Drive. Seating capacity of 85 to 90 with a separate entrance to the rooftop location. A restroom separate from Cosmic Bounce is being constructed. Local beer and wine would be served. The wine bar would be seasonal and they anticipate being able to open yet this summer.

Lisa and Paul Roberts spoke on behalf of Angler's Avenue. They are interested in putting in a seasonal tiki bar in the lot to the east of Angler's, but not until next summer. They have not yet contacted the Redevelopment Authority about this proposed business and would need to do that before being able to apply for a license.

Manasty Lee spoke on behalf of Dragon Bar at 13th and Huron. They presently have a beer and wine license but want a full liquor license. Seating capacity is approximately 50 people. They are primarily a bar but also have a side restaurant.

A representative for Mike Eggen spoke regarding Mr. Eggen's proposed pool hall at 1514 South 12th Street (one door south of Al & Al's). Mr. Eggen does not own the building but would lease from Jeff Rittenhouse. They would have six to eight pool tables and would serve bar food. Mr. Eggen also owns Gotta Getcha In Oasis. They have not contacted the Planning Department yet regarding this project.

#### 2.5 Discussion and action regarding granting opportunity to apply for available "Class B" alcohol beverage licenses

Motion by Alderperson Draughon, seconded by Alderperson Trester, to invite Aaron Sloma and Scott Versey to each apply for one of the available "Class B" alcohol beverage licenses within ten days. All ayes; motion carried.

Alderperson Draughon was excused from the meeting at 3:31 p.m.

#### 2.6 Presentations by potential applicants for available "Class A" alcohol beverage licenses

Navroop Gill appeared before the committee to discuss the liquor store he wants to open at 1130 Geele Avenue. Mr. Gill did not have any plans with him, but stated he has contacted the Planning Department and requested the paperwork which he needs to complete and return in order to get the review process started. Jason Hunt spoke and indicated he lives 2-1/2 blocks away from this location and he is in favor of the project.

Basudev Adhikari appeared before the committee regarding the new J Mart gas station he plans to build at North 15th Street and Geele Avenue. Mr. Adhikari wants to have a liquor store connected to the gas station, but he did not have a copy of the final plans with him. He said he has received approval from the Planning Department.

#### 2.7 Discussion and action regarding granting opportunity to apply for available "Class A" alcohol beverage licenses

Alderperson Trester and Alderperson Lessard both indicated they have received numerous phone calls from constituents stating they don't want a liquor store in the Geele Avenue neighborhood. Captain Veeseer indicated that he did not feel another liquor store is a good idea in that neighborhood. Motion by Alderperson Trester, seconded by Alderperson Hermann, to not grant an opportunity to any of the interested parties to apply for the available "Class A" alcohol beverage licenses. Three ayes; motion carried.

Charter Ord. No.  / - 16 - 17. By Alderpersons Lewandoske, Hermann and Rabe. August 1, 2016.

AN ORDINANCE (being subject to the home rule provisions of sec. 66.0101 of the Wisconsin Statutes) to maintain the number of alderpersons in the City of Sheboygan at 16.

THE COMMON COUNCIL OF THE CITY OF SHEBOYGAN DO ORDAIN AS FOLLOWS:

Section 1. The City of Sheboygan hereby elects, pursuant to the provisions of Sec. 62.09(1)(b) of the Wisconsin Statutes and the home rule provisions of Sec. 66.0101 of the Wisconsin Statutes, to repeal the provisions of Charter Ordinance No. 1-15-16, which reduced the number of alderpersons in the City of Sheboygan from sixteen (16) to ten (10) by the 2018-2019 council year.

Section 2. Section 2-224(c) of the Sheboygan Municipal Code, relating to terms of office for alderpersons, shall be repealed and recreated to read as follows:

"Sec. 2-224. *Terms.*

. . .

(c) *Alderpersons.* The term of the office of alderperson shall be two years. The alderpersons shall be residents of the aldermanic district from which they are elected, and eight of their number, representing one alderperson from each aldermanic district, shall be elected each year."

Section 3. All ordinances or parts thereof in conflict with the provisions of this ordinance are hereby repealed to the extent of such conflict.

Section 4. This is a charter ordinance and shall take effect sixty (60) days after its passage and publication, unless within such sixty (60) days after its passage and publication a referendum petition shall be filed as provided in sec. 66.0101 of the Wisconsin Statutes, in which event this ordinance shall not take effect until it shall have been submitted to a referendum of the electors and approved by a majority of the electors voting thereon.
