1. OPENING OF MEETING

1.1 Call meeting to order

Chairperson Lessard called the meeting to order at 2:31 p.m.

1.2 Pledge of Allegiance

The Pledge of Allegiance was recited.

1.4 Approval of the minutes of the January 12, 2016 meeting

A motion to approve the minutes of the previous meeting held January 12, 2016 was made by Ald. Wolf and seconded by Ald. Draughon. **All ayes; motion approved.**

2. ITEMS FOR DISCUSSION AND POSSIBLE ACTION

Eugene A. Osbahr failed to appear before the committee. Ald. Wolf moved, seconded by Ald. Hermann, to deny the license application based upon Mr. Haleem's record of violations related to the licensed activity, his record as a repeat law violator, and his failure to cooperate with the committee.

Michael E. Baratta appeared before the committee to discuss his application. After discussion of his record and his failure to include violations on his application, Ald. Wolf moved, seconded by Ald. Trista J. Windorski failed to appear before the committee. Ald. Wolf moved, seconded by Ald. Draughon, to request via certified mailing Ms. Windorski's appearance before the committee at its February 9th meeting. **All ayes; motion approved.**

Troy Allen Shaw failed to appear before the committee. Ald. Wolf moved, seconded by Ald. Hermann, to request via certified mailing Mr. Shaw's appearance before the committee at its February 9th meeting. **All ayes; motion approved.**

2.3 Possible action regarding Alc. Bev. Lic. No. 1040-Brennans on Michigan (Thomas M. Brennan, Agent)

Ald. Lessard recused herself from any discussions regarding Brennans on Michigan and indicated that she would abstain from voting on this matter. Vice Chairperson Ald. Wolf chaired the meeting beginning at 2:39 p.m.

Thomas M. Brennan and Peggy Brennan appeared before the committee. Peggy Brennan indicated that they had suspended the bouncer for a period of time and their bartenders have been instructed to always card patrons and not just assume that the bouncer has accurately done so. Ald. Hermann moved, seconded by Ald. Draughon, to issue a warning to Brennans on Michigan regarding the sale of alcohol to an underage person at Brennans on December 26, 2015. **Four ayes and one abstention (Ald. Lessard); motion approved.**

Ald. Lessard resumed chairing the meeting at 2:44 p.m.

2.4 Update regarding 90-day extension granted to Alc. Bev. Lic. No. 3136-Frank's Place (Scott A. Wachowski, Agent)

CA Adams informed the committee that Frank's Place did open for business right before the extension expired and, therefore, they are in compliance with the ordinance.
