1. OPENING OF MEETING

1.1 Call meeting to order

Chairperson Lessard called the meeting to order at 2:32 p.m.

1.4 Approval of the minutes of the December 29, 2015 meeting

A motion to approve the minutes of the previous meeting held December 29, 2015 was made by Ald. Wolf and seconded by Ald. Draughon. **All ayes; motion approved.**

2. ITEMS FOR DISCUSSION AND POSSIBLE ACTION
