1.4 Approval of the minutes of the November 10, 2015 meeting

A motion to approve the minutes of the previous meeting held November 10, 2015 was made by Ald. Lessard and seconded by Ald. Wolf. **All ayes; motion approved.**

2. ITEMS FOR DISCUSSION AND POSSIBLE ACTION
