AN ORDINANCE relating to adding no parking 7:00 a.m. to 4:00 p.m. on school days only on the west side of South 8th Street north of Georgia Avenue.

THE COMMON COUNCIL OF THE CITY OF SHEBOYGAN DO ORDAIN AS FOLLOWS:

Section 1. Pursuant to Section 118-126 of the Municipal Code entitled, "Prohibitions and Restrictions Authorized," the west side of South 8th Street from 120 feet north of the north curb line of Georgia Avenue to 182 feet north of the north curb line of Georgia Avenue to 120 feet north of Georgia Avenue is hereby added to the list of locations where parking is prohibited from 7:00 a.m. to 4:00 p.m. on school days only.

Section 2. The Department of Public Works and the Police Department are hereby authorized and directed to install the signs to give notification of the aforementioned parking restriction.

Section 3. All ordinances or parts thereof in conflict with the provisions of this ordinance are hereby repealed to the extent of such conflict, and this ordinance shall be in effect from and after its passage and publication.

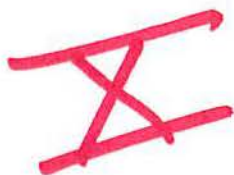

AN ORDINANCE relating to adding no parking, stopping or standing anytime on the west side of South 8th Street north of Georgia Avenue.

THE COMMON COUNCIL OF THE CITY OF SHEBOYGAN DO ORDAIN AS FOLLOWS:

Section 1. Pursuant to Section 118-126 of the Municipal Code entitled, "Prohibitions and Restrictions Authorized," the west side of South 8th Street from the north curb line of Georgia Avenue to 50 feet north of Georgia Avenue is hereby added to the list of locations where no parking, stopping or standing is permitted.

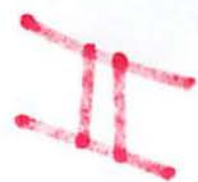
