1. OPENING OF MEETING

1.1 Call meeting to order

Chairperson VanderWeele called the meeting to order at 2:01 p.m.

1.2 Pledge of Allegiance

The Pledge of Allegiance was recited.

1.3 Introduction of Committee members, staff and guests

1.4 Approval of the minutes of the July 28, 2015 meeting

A motion to approve the minutes of the previous meeting held July 28, 2015 was made by Ald. Lessard and seconded by Ald. Hermann. **All ayes; motion approved.**

2. ITEMS FOR DISCUSSION AND POSSIBLE ACTION

2.1 R.O. No. 39-15-16 (6-1-15) Submitting various license applications [individuals] for the period ending December 31, 2015 and June 30, 2017. Various License Applications: Bev. Op. Lic. [NEW] App. No. 8558 (Steffani L. Butler); Bev. Op. Lic. [RENEW] App. No. 2440 (MarthaJo Butzen)

Steffani L. Butler failed to appear before the committee. Ald. Lessard moved, seconded by Ald. Hermann, to deny the license application based upon Ms. Butler's failure to accurately reveal all relevant convictions on her beverage operator's license application, her record of violations related to the licensed activity, her record as a repeat law violator, and her failure to cooperate with the committee. **All ayes; motion approved.**

MarthaJo Butzen failed to appear before the committee. Ald. Lessard moved, seconded by Ald. Hermann, to deny the license renewal application based upon Ms. Butzen's record of a recent

conviction in 2014 related to the licensed activity, and her failure to cooperate with the committee.
