1. OPENING OF MEETING

1.1 Call meeting to order

Chairperson VanderWeele called the meeting to order at 2:00 p.m.

1.2 Pledge of Allegiance

The Pledge of Allegiance was recited.

1.3 Introduction of Committee members, staff and guests

1.4 Approval of the minutes of the May 12, 2015 meeting

A motion to approve the minutes of the previous meeting held May 12, 2015 was made by Ald. Lessard and seconded by Ald. Hermann. **All ayes; motion approved.**

2. ITEMS FOR DISCUSSION AND POSSIBLE ACTION

2.1 R.O. No. 10-15-16 (5-4-15) Submitting various license applications for the period ending December 31, 2015 and June 30, 2016 and June 30, 2017. Various License Applications: "Class B" Liquor Lic. [NEW] App. No. 3126-Brian's Down Under Music Bar (Brian Zaversnik, Agent); Taxicab Driver Lic. [NEW] App. No. 6868 (Ben T. Klinzing)

Brian Zaversnik appeared before the committee to discuss his application. After discussion of his record and his failure to include violations on his application, Ald. Lessard moved, seconded by Ald. Hermann, to grant the license contingent upon the application being corrected, and with a warning to include all relevant information on future applications. **All ayes; motion approved.**

Ben T. Klinzing appeared before the committee to discuss his application. After discussion of his record and his failure to include violations on his application, Ald. Hermann moved, seconded by Ald. Lessard, to deny the license application based upon Mr. Klinzing's failure to accurately reveal all

relevant convictions on his taxicab driver's license application, his record of violations related to the licensed activity, and his record as a repeat law violator. **All ayes; motion approved.**

2.2 Hearing on the appeal of Steven J. Widucki finding his dog to be a vicious animal, pursuant to Sec. 18-47(i)(2), Sheboygan Municipal Code

Ald. VanderWeele called the hearing to order at 2:11 p.m. with appearances by CA Adams to advise the committee in their function as finder of law and fact, Police Chief Chris Domagalski on behalf of the Sheboygan Police Department, and Steven J. Widucki appearing in person.

Chief Domagalski presented his case and provided the committee with details regarding the various incidents involving the dog named Sophie and his initial determination that the dog is a vicious animal.

Officer Paul Graening and Officer Sarah Blodgett were present as witnesses on behalf of the Sheboygan Police Department and were sworn in and questioned by Chief Domagalski. Documents and photos were marked as police department's Exhibits 1, 1A through 1C, and 2 and offered as evidence. Copies were provided to Mr. Widucki. Mr. Widucki also questioned Officer Graening.

Steven J. Widucki presented his case and informed the committee that he was appealing the determination because he does not believe that his dog Sophie is vicious. Mr. Widucki was sworn in and presented his narrative of the various incidents involving Sophie. CA Adams allowed Chief Domagalski to ask Mr. Widucki questions. Chief Domagalski requested that Mr. Widucki read aloud his written statement dated March 29, 2015 which was then marked as police department's Exhibit 4B.

Michele Schillingowski was sworn in and questioned by Mr. Widucki. Ms. Schillingowski presented photos of Sophie which were marked as defendant's Exhibits 1 through 9. Chief Domagalski cross-examined Ms. Schillingowski and offered as evidence dog bite photos marked as police department's Exhibits 4A and 5A.

Dalys Tveten was sworn in and questioned by Mr. Widucki.

Chief Domagalski recalled Officer Blodgett and she answered questions regarding police reports which were marked as police department's Exhibits 2 and 5.

Chief Domagalski called Officer Steven Schnabel as a witness and he was sworn in and answered questions regarding police reports which were marked as police department's Exhibits 3 and 4.

There were no objections to the following exhibits being made part of the record: Police department's exhibits 1, 1A, 1B, 1C, 2, 3, 4, 4A, 4B, 5, 5A; defendant's exhibits 1-9. CA Adams

indicated that the Vicious Dog Notice dated April 8, 2015 and also the letter from Mr. Widucki dated May 7, 2015 appealing the vicious dog finding were also being made a part of the record.

Closing statements were made by Chief Domagalski and Steven J. Widucki.

The committee found that Mr. Widucki's dog Sophie caused a serious injury to a person, and attacked a person in such a manner as to result in an injury to the person when such person was conducting himself peacefully and lawfully on property other than that of the owner of the attacking dog. Ald. Lessard moved, seconded by Ald. Hermann, to uphold Chief Domagalski's determination that Sophie is deemed vicious. **All ayes; motion approved.**


