1. OPENING OF MEETING

1.1 Call meeting to order

Chairperson VanderWeele called the meeting to order at 2:00 p.m.

2.7 Presentations by potential applicants for available "Class B" alcohol beverage licenses

There is presently one "Class B" alcohol beverage license available. Licensing Clerk Cinda Langhoff had attempted to notify all parties interested in a license that presentations were on today's agenda. The only person to appear before the committee to present his business plan and answer questions from the committee was Ignacio Mendiola. Mr. Mendiola's other business with an alcohol beverage license is Geno Nottolini's Pizza.

Mr. Mendiola spoke regarding the property at 1235 Indiana Avenue (the old Standard Hall). He plans to enter into a lease agreement with the party who recently purchased the property. He would operate a bar and a party room there as the Geno's location does not have enough space for parties. He feels they could be ready to open in May.
