1. OPENING OF MEETING

1.1 Call meeting to order

Chairperson VanderWeele called the meeting to order at 2:00 p.m.

The Pledge of Allegiance was recited.

1.4 Approval of the minutes of the December 9, 2014 meeting

A motion to approve the minutes of the previous meeting held December 9, 2015 was made by Ald. Thiel and seconded by Ald. Lessard. **All ayes; motion approved.**

2. ITEMS FOR DISCUSSION AND POSSIBLE ACTION

2.1 R.O. No. 193-14-15 (12-1-14) Submitting various license applications for the period ending December 31, 2014, December 31, 2015 and June 30, 2016. Various License Applications: Bev. Op. Lic. App. No. 0625 (Jamie S. Zuniga); Taxicab Op. Lic. App. No. 0621 (Mandi L. Kunstman)
