1. OPENING OF MEETING

1.1 Call meeting to order

Chairperson VanderWeele called the meeting to order at 2:00 p.m.

1.2 Pledge of Allegiance

The Pledge of Allegiance was recited.

1.3 Introduction of Committee members, staff and guests

1.4 Approval of the minutes of the September 9, 2014 meeting

A motion to approve the minutes of the previous meeting held September 9, 2014 was made by Ald. Thiel and seconded by Ald. Lessard. **All ayes; motion approved.**

2. ITEMS FOR DISCUSSION AND POSSIBLE ACTION

2.1 R.O. No. 119-14-15 (9-2-14) Submitting various license applications for the period ending June 30, 2015 and June 30, 2016. Various License Applications: Bev. Op. Lic. App. Nos. 0546 (Kenneth J. Goetsch), 5826 (Lyndsey J. Kailing), 7647 (Aimee N. Orr-Sanchez), 0545 (Jared P. Romanoski), 0541 (Casey A. Vogel)

Kenneth J. Goetsch failed to appear before the committee. Ald. Thiel moved, seconded by Ald. Matichek, to request via certified mailing Mr. Goetsch's appearance before the committee at its October 14th meeting. **All ayes; motion approved.**

Lyndsey J. Kailing appeared before the committee to discuss her application. After discussion of her record, Ald. Matichek moved, seconded by Ald. Thiel, to grant the license. **All ayes; motion approved.**

Aimee N. Orr-Sanchez did not appear, but had contacted the City Attorney's Office to indicate that she was unable to appear. Ms. Orr-Sanchez was instructed to appear at the October 14th meeting. Ald. Thiel moved, seconded by Ald. Lessard, to hold the application until the October 14th meeting and to call in Ms. Orr-Sanchez by regular mail. **All ayes; motion approved.**

Jared P. Romanoski appeared before the committee to discuss his application. Lt. Teunissen made a negative recommendation. After discussion of Mr. Romanoski's record and his failure to include violations on his application, Ald. Matichek moved, seconded by Ald. VanderWeele, to deny the license application based upon Mr. Romanoski's failure to accurately reveal all relevant convictions on his beverage operator's license application, his record of violations related to the licensed activity, and his record as a repeat law violator. **Two ayes, one nay (Ald. Lessard) and one**

abstention (Ald. Thiel); motion approved.

Casey A. Vogel failed to appear before the committee. Ald. Thiel moved, seconded by Ald. Matichek, to request via certified mailing Mr. Vogel's appearance before the committee at its October 14th meeting. **All ayes; motion approved.**

2.2 R.C. No. 162-14-15 (9-15-14) - Bev. Op. Lic. App. No. 0506 (Ian E. Munro)

Ian E. Munro appeared before the committee to discuss his application. After discussion of his record and his failure to include violations on his application, Ald. Matichek moved, seconded by Ald.
