3.1 Res. No. 68-20-21 (8-3-20) A Resolution authorizing application for the Edward Byrne Memorial Justice Assistance Grant (JAG) Program Fiscal Year 2020 Local Solicitation and entering into a Memorandum of Understanding with Sheboygan County

Chief Domagalski informed the committee that the City and the County have a 20-year history of entering into a MOU and sharing the proceeds of this grant.
