BACKGROUND / ANALYSIS:

The Salvation Army held the Salvation Ride at South Pier on July 9, 2016. The parcels they used as authorized by the Redevelopment Authority was next to Spaceport and the parking lot to the west of Spaceport.

STAFF COMMENTS:

Phase 1 of the Portscape Apartment project will be finishing up Spring/Summer of 2017 and Phase 2 consisting of 35 units will begin during July/August of 2017. With the construction going on, the property that Salvation Army previously used will not be available. The change to the riverfront will require the applicant to obtain electrical power from a generator.

ACTION REQUESTED:

Motion to approve the request provided that Salvation Army will consider relocating the event to the parcels adjacent to the river or the end of South Pier Drive at the circle contingent upon the completion of an Events Application in the City Clerk's office, hold-harmless agreement, certificate of insurance and \$50 user fee.
